I request that this tournament be sanctioned by ASA and I agree to the following requirements:

- 1) All teams participating in the tournament will be ASA registered.
2) All umpires working the tournament will be ASA registered.
3) The tournament director will collect travel permits from out-of-state teams.
4) For Adult Tournaments the tournament director agrees to pay a \$10 sanction fee for tournaments with eight teams or less or \$25 for the tournament of nine teams or more. For Junior Olympic Youth Tournaments the fee is \$5.00 per age division.
5) Invitational Tournaments may establish rules and regulations for their tournament, provided such rules and regulations are not in conflict with the ASA Code. Joint ventures with competing organizations are prohibited without the expressed written consent of the State Commissioner.
6) No invitational tournament may be conducted which conflicts with state championship play for that division of play.
7) Junior Olympic (Youth). The sale or possession of beverages that contain alcohol on the softball complex is prohibited.
8) A copy of the tournament invitation and tournament bracket must be sent to the Iowa ASA State Office.
9) No player or coach disbarred or suspended by ASA is eligible to enter the tournament or be listed on a team roster.
10) Failure to comply with the above teams may result in this tournament being place under suspension. In addition, ASA may suspend individuals responsible for this tournament if it is found that the tournament is in violation of the ASA Code.
